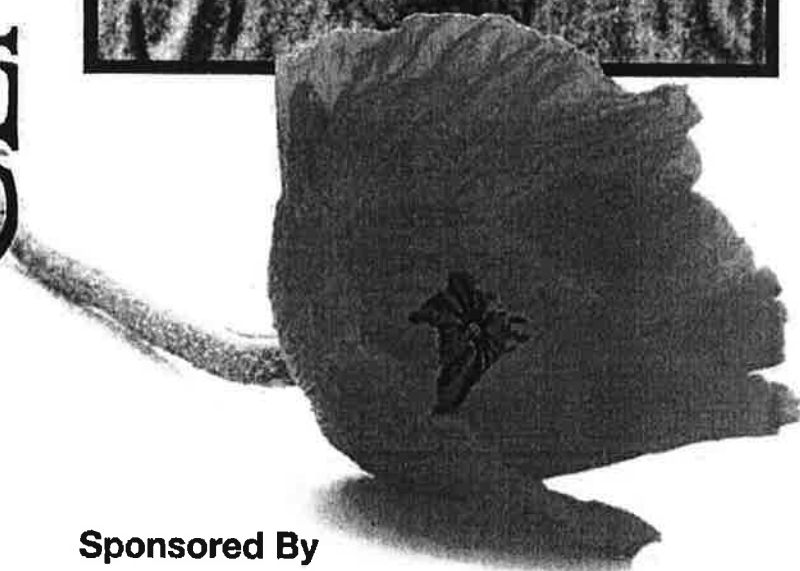

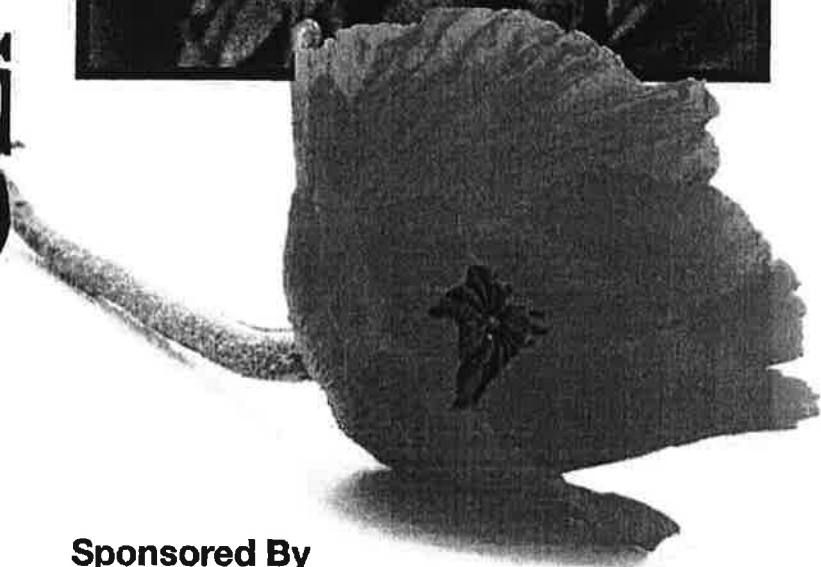

RE : Approval of Employee Benefit Plan -- Resolution 2018-23 Employee Benefit Plan

The administration will meet with Landmark Insurance Associates on Tuesday, October 16<sup>th</sup>, 2018 to discuss the City's options for benefits plans to be offered to eligible employees effective December 1, 2018. It is anticipated that several plan options from several different carriers will be reviewed.

Being that plan options will not be ready to present to the Administration until the morning of the October 16<sup>th</sup>, 2018 work session date, there is not information to present to Council at this time. After the scheduled meeting with Landmark on Tuesday morning, the Administration will work to compile the information into a presentation for Council that will note the Administration's recommendation for plan offerings. The presentation is expected to be made during the special called meeting of Council that is set to be held before the regularly scheduled work session on October 16<sup>th</sup>, 2018.

Unless Council should direct the Administration otherwise or should need additional time to consider, the Administration will seek approval of the recommended Employee Benefit Plan during the special called meeting. The Administration would make this request in an attempt to allow enough time for an adequate enrollment period, to make sure new coverage is in place at the time of the current coverage's expiration, and to ensure that members are provided with ID cards in a timely manner.

## RESOLUTION 2018-23

WHEREAS, the City of Stone Mountain seeks to employ individuals capable of outstanding performance in public service; and

WHEREAS, employee benefits are an aide in the recruitment of highly skilled workers; and

WHEREAS, medical and dental benefit plans are commonly used by municipalities to attract highly skilled workers;

NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the City of Stone Mountain, Georgia, this \_\_\_\_\_, day of \_\_\_\_\_ 2018, as follows:

1. that the medical insurance plan known as the \_\_\_\_\_ Plan is the official medical benefits plan for the City of Stone Mountain effective December 1, 2018;
2. that the City of Stone Mountain will offer the plan known as the \_\_\_\_\_ as a buy-up option for employees, with the difference in the employee premium cost for the buy-up plan to be paid by the employee who elects the buy-up plan during the policy year ending November 30, 2019;
3. that eligible dependents of the employee may participate in the medical benefits plan provided that one hundred percent (100%) of the premium for the dependents is paid by the employee;
4. that the dental insurance plan provided by \_\_\_\_\_ is the official dental benefits plan for the City of Stone Mountain;
5. that employees, eligible dependents of the employee and COBRA participants in the plan may participate in the dental benefits plan provided that one hundred percent (100%) of the premium is paid by the employee or COBRA participant in the plan;
6. that employees who experience an event qualifying for COBRA continuation coverage and their eligible dependents may participate in the medical and/or dental plan for a period of eighteen months following the month of termination provided that one hundred percent (100%) of the premium is paid by the COBRA participant;
